




- 小觀設計的註冊,由註冊當日開始生效,而註冊日期則可追溯至註冊申請的提交日期。除聯繫或相應外觀設計外,外觀設計的註冊的首段有效期為自註冊申請的提交日期起計的5年。註冊有效期可每次再延展5年,但總共不得超過自註冊申請的提交日期起計的25年。
  - Registration of a design takes effect from the Date of Registration, which is backdated to the filing date of the application for registration. Except for associated or corresponding designs, the initial period of registration of a design is 5 years beginning on the filing date of the application for registration. The period of registration may be extended for additional periods of 5 years each but the total period of registration may not exceed 25 years beginning on the filing date of the application for registration.


Front View




Rear View




